Schloendorff v. Society of New York Hosp., 105 N.E. 92, 93 (N.Y. 1914)

The universal right of Informed Consent has been the law for well over a century, starting with a famous New York case in 1914 (decided by Judge, later Justice Cardoza) holding that it is an assault and battery to engage in a medical intervention without Informed Consent, even if the intervention was intended to benefit the recipient.
